# Keeping your children safe at Madresfield CE Primary School

## What Procedures are in place to keep your children safe?

- All staff, governors and volunteers receive safeguarding, online safety and Prevent training and this is updated regularly
- We have a fully trained Designated Safeguarding Lead and Deputy Designated Safeguarding Lead on our staff
- The DOWMAT buys in safeguarding support for all of its academies from the local authority
- All visitors to the school must sign in before entering the building and are supervised if we do not hold a current DBS (Disclosure and Barring Service) check for them
- All staff, governors and volunteers have enhanced DBS checks
- Other checks that our staff have include: enhanced DBS checks, police checks, overseas checks, online checks, prohibition checks, barred list checks, references
- During employment, any issues that we are alerted to are investigated immediately involving the appropriate agencies with the DOWMAT overseeing our procedures
- We take and follow advice from the Local Authority Designated Officer (LADO) where necessary

## Safeguarding Audits

We have annual safeguarding audits. Our most recent DoWMAT audit was on the 15<sup>th</sup> January 2025. The outcome was that safeguarding is effective here at Madresfield.

## Safeguarding is everyone's responsibility

In our school, safeguarding is everyone's responsibility and we are very fortunate to have a deeply committed staff who work hard to ensure that the children receive a good education in a safe and respectful environment. We also provide monthly safeguarding newsletters which are sent out to parents monthly.
